Purchase price includes Goldendoodle Puppy, 12-month health guarantee, veterinary exam, microchipping, current on all vaccinations and worming's, record of vaccinations and worming's.

Delivery/Pickup Arrangements

To pick up your puppy, an appointment must be made at the time the deposit is paid. If a puppy needs to be held past 8 weeks of age, then arrangements **MUST** be made with breeder. Failure to do so may cause loss of deposit and puppy being placed for adoption again. If a puppy needs to be held, buyer will be responsible for continued vet care and maintenance. Buyer will pay an additional \$_____ per week plus vet care (ie: shots, worming, etc) **ALL PUPPIES MUST BE PAID IN FULL UPON PICKUP.**

Cost of shipping (if applicable) is at the buyers expense \$_____, this includes the flight, flight insurance, crate, bedding, toy, stainless steel food and water bowl.

PUPPY, SHIPPING, AND ANY ADDITIONAL COSTS MUST BE PAID 14 DAYS PRIOR TO SHIPPING Cost of the airline flight is **NON REFUNDABLE.**

General Care and Treatment Conditions

1. The buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping puppy/dog parasite free and up-to-date vaccinations, proper nutrition, which consists of a good quality professional diet given at regular intervals, and fresh water available at all times. The buyer promises to provide a safe environment for the puppy/dog and never allow the puppy/dog to roam freely without proper fencing or supervision. If at any time seller becomes knowledgeable that adequate living conditions, grooming and care are not being provided to the dog, buyer will forfeit ownership to seller and seller will resume ownership of the dog immediately. Any and all legal fees and expenses necessary to do so will be at the buyer's expense. Training classes are recommended and encouraged for a happy relationship for a between a dog and family.
2. The seller guarantees this puppy/dog is of sound health and temperament at the time of sale. A health record of all vaccinations and worming will be provided.
3. The buyer may optionally take the puppy/dog to a licensed veterinarian of his/her choice within 72 hours of pick up for a physical examination. If puppy is determined to be in ill health, the cause of which is clearly attributable to the seller, the puppy and signed written diagnosis from a licensed veterinarian must be returned within 48 hours for a refund less DEPOSIT. Shipping is NOT Included.

4. The seller provides a health guarantee of up to 12 months of age against the following: hip dysplasia- this must be diagnosed by an OFA report and blindness caused by progressive retinal atrophy as confirmed by a board certified canine ophthalmologist. The buyer **MUST** immediately contact the breeder within 5 days of any diagnosis or health concerns. Breeder must also be kept in constant contact throughout treatment of puppy/dog. Breeder will require vet records but not limited to and tests while treatment/diagnostics are completed. If buyer fails to notify seller of puppy/dog diagnosis or health concerns than buyer will be in breach of contract and will void health guarantee on puppy listed. Once the buyer and seller's veterinarian has confirmed a diagnosis and determined that the puppy would be unable to live a quality of life as a companion, half (\$850.00) the purchase price would be refunded to the buyer.
5. The seller does not guarantee against shedding, allergic reactions, or allergies. Seller cannot also guarantee size or color of puppy.
6. Recommendations are to have the puppy spayed/neutered at the age recommended by their veterinarian (usually 6-7 months of age). Puppy should be spayed/neutered by 8 months of age.
7. If at any time the buyer can no longer retain possession of the puppy/dog, the seller is to be notified and given first option of resuming full ownership to locate a new home for the puppy/dog. **NO REFUNDS WILL BE PROVIDED.** The puppy/dog will be returned with all records. Should any circumstances arise that effects the quality of the life of the puppy/dog. The seller reserves the right to approve/prohibit any transfer of the puppy/dog to a third party. Under no circumstances will the puppy/dog be sold, leased, traded, or given away to any pet shop, research laboratory, animal shelter, auction and/or similar facility.
8. The buyer agrees to contact the seller immediately if any questions or concerns arise about the dog, such as diet, health, housing and training, behavior, and temperament. The buyer agrees to keep the seller informed of any treatment as it occurs. This provides the seller with important feedback and information on the health of the puppy/dog for future generations.
9. It is understood at the time of the sale that this is a companion puppy/dog and it is a representative of its breeds (Golden Retriever, Poodle, Goldendoodle). It is structurally and temperamentally suited as a companion.
10. If any legal action is taken to enforce any provision of this contract, said legal action shall be brought in the appropriate court located in Carrollton, Texas in Denton County. The laws of the State of Texas shall be used to interpret the provisions of the contract and shall be applied by the court in rendering judgments in any legal action brought by either party. The puppy buyer agrees to using arbitration instead of settling in court if the breeder chooses this option.

The preceding paragraphs contain conditions established for the wellbeing of the dog and to uphold and maintain the reputation of quality that DandiDoodles.com has established. The buyer's agreements will continue for the life of the dog and the seller will have the right to enforce the agreement.
